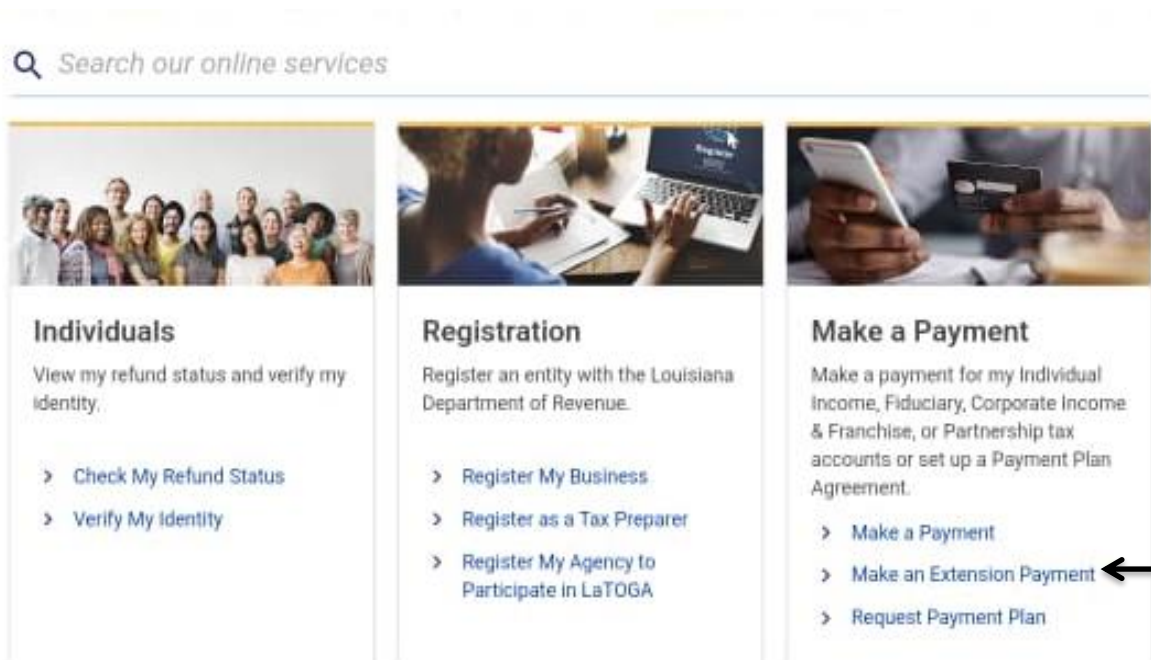




How can I make an extension payment?

To avoid interest and delinquent payment penalties, taxpayers must remit their taxes by the due date for Individual Income, Fiduciary, or Corporate Income & Franchise tax accounts. Extension payments can only be made for the current filing period.
